**SECRETARY'S REPORT:**

One item of concern is "Grants", we should look at listing these on the website so that viewers can see what is being worked on.

**TRAIL REPORTS:**

Due to the excessive winds, there have been several trees down on the trails; this is being worked on. The club has a few saws available for use; if you are willing, please take one when riding to help clear the downed trees.

Trail 3 is in excellent shape; however the corners are already pushing out and are showing wear. The same is true with 31S. We need to back-blade and gravel these areas. Steve Lobitz talked with Donny Mrotek and we now have until July 1<sup>st</sup> to get some of this work done. Tom Sirinek will haul in the gravel as soon as he can.

We need to keep up the Private Land; some areas are getting bad and need to be seriously looked at. Machines are available to work the trails, we need volunteers to help out.

Tom Sirinek is scheduled to haul in gravel on 31S, 31N, and by Chit Chat as soon as his schedule allows. Steve Lobitz has \$8500 allowed for this in Sawyer County.

There were some problems with ATVer's riding in the waterways; Tim Lee will put up some signage in this area to deter riders from going off the trail. If anyone notices riders riding or performing illegal activities, it is encourage to report them to the DNR immediately.

Dahle will be working by Chit Chat as soon as possible with the dozer. There will be gravel and culvert work done.

Widiker will be working in the Dalen Road area - Craig Minnik will work with him on this. There is not a lot of manual work to be done, it is mostly machine work.

Over the Memorial Day weekend, there seemed to be quite a bit of ATV action - that is a great thing to see!

Something needs to be done with the waterhole on 31S right off the Tuscobia. Steve Lobitz and Tim Lee will take a look at it to determine some options. There seems to be some controversy over who is responsible for this portion of the trail, Kathy O or the club. Steve will contact Kathy to see if they can get this situation settled

Bids are being put out for trails 3/27 and the work should be completed by September.

#### **ATV SAFETY CLASS:**

The safety class will begin next week, Monday, Tuesday and Wednesday. About 19 students have shown interest. We will need about 8-12 machines and refreshments served after the final class.

#### **KIDS GAMES AT DOOLITTLE PARK:**

We need volunteers to help out. Lisa will organize the event again this year; however, she will not be running the event the day of. This year the date is set for July 16<sup>th</sup>. As of next year, Lisa will not be involved with the event at all, she is handing the reins over to someone new. A motion was made by Judy Martiny to donate \$200 towards the Kid's Games event to purchase a bike and supplies, this was 2<sup>nd</sup> by Tim Lee.
